FSU CBE STUDENTS WIN AWARDS AT SAM CONFERENCE IN ARLINGTON, VIRGINIA

The FSU Chapter of the Society for Advancement of Management (SAM) participated in the 2018 SAM International Business Conference in Arlington, VA. This year the SAM members competed in the Team Management Case Competition and the Extemporaneous Speaking Competition. The conference also recognized chapter, student, and faculty advisor accomplishments. CBE students Rai-Jhan Davis, William "Ben" Rogers, and Lerona Pollard competed in the events.

The Extemporaneous Speaking Competition is a new student event at the SAM International Business Conference. This event allowed students to showcase their analytical and speaking skills under significant time constraints. FSU Senior Lerona Pollard came in first place in the Extemporaneous Speaking event. The judges were impressed with her ability to clearly and succinctly address a current business-related problem and provide a viable solution. She received an offer to work with the Ryder company.

The chapter received the second-place trophy for the Campus Chapter Performance Award. The Campus Chapter Performance Award was designed to reward SAM chapters for outstanding chapter sponsored events, student enrichment initiatives, and practicing good management skills.

Additionally, SAM members were recognized for their academic excellence and chapter participation at the conference. Rai-Jhan Davis received a SAM Regional Outstanding Student Award. William Acox received both the SAM Regional and National Outstanding Student Award. This very selective award is based on the student's GPA, extracurricular activities, and chapter service to determine the winners. Finally, Dr. Christopher Torrance received honors as an Outstanding Faculty Advisor. The SAM Board of Directors select only three SAM chapter advisors to receive this annual award. We are very proud of our CBE students' ability to represent FSU on an international stage and their continued dedication to academic excellence.

CONGRATULATIONS TO FSU STUDENTS FOR WINNING 4TH PLACE IN A NATIONWIDE CONTEST

HBCU BATTLE OF THE BRAINS: A VALUABLE EXPERIENCE FOR BUSINESS STUDENTS



Fayetteville State University students were invited to the second annual HBCU Battle of the Brains held at the world renown SXSW (South by Southwest) in Austin, TX. This was FSU's first invitation to the competition as only seven teams competed last year. Drs. Nikolai Wenzel, Mehdi Kobdeh, and Oluwatope Mitchell mentored the team before and after the competition.

HBCU Battle of the Brains and Hackathon is a competition pitting teams from HBCUs around the country against one another in a 24-hour challenge to create and pitch a feasible, marketable solution to a real-world business problem with a technology component. This year's challenges included providing solutions to reaching millennials for Home Depot and the NFL, as well as a finding an alternative to the "normal" collegiate experience for individuals facing time restrictions or financial difficulties. The competition was challenging as 23 teams of students competed, 4 from North Carolina universities alone.

Home Depot was one of the major sponsors of the event, graciously providing students with the space for the 24-hour challenge and welcome reception at their Home Depot Austin Technology Center. At the welcome reception Thursday night, students got their first look at the competition. Mingling with the other students helped create an atmosphere of comradery and fellowship, but the teams came to compete and compete they did! Shortly after arriving Friday morning teams were assigned individual rooms to work on their solutions. Advisers were strictly forbidden; however many high-level executives from sponsoring companies walked

around and worked with students to identify problems and ask questions to further the student's solutions. Working overnight students created a business plan, website, presentation, and elevator pitch to be reviewed by judges. Seven teams were then selected to pitch their ideas at SXSW to judges with little sleep or time to practice their presentations.

This year's first place winners from Florida A&M won \$25,000. Second place went to Morgan State University with a prize of \$15,000. Third place was Grambling State University for \$10,000. All teams that won did an amazing job with solution development and presenting.

Although Fayetteville State's team did not win the competition, they all agree that the experience was well worth it! Not only did the teams get to compete in the Battle of the Brains, but were granted access to many of SXSW's best panels, interactive showcases, and a brunch with top HR personnel from sponsoring companies such as Home Depot, the NFL, Home Away, and Dell. A highlight of the experience was attending panels with guest speakers Tiffani Smith-Anoa'i, an executive vice president at CBS Entertainment, and actor, producer, entrepreneur, Darryl Bell.

This event was truly a work of the heart for sponsors. Gregory Gibson Jr., the founder of HBCU Battle of the Brains, relayed that many of the staff go unpaid for their efforts, but are extremely grateful to give HBCU students the experience and opportunity of competing, while meeting hiring personnel from various companies. Student having participated this year look forward to mentoring next year's Fayetteville State team!

FSU BUSINESS STUDENTS NETWORK WITH STUDENTS AROUND THE COUNTRY THROUGH AEI

Fayetteville State University's Phi Beta Lambda, Alpha Kappa Chapter, dedicated time to donate gifts and supplies to the pediatric ward of Cape Fear Valley Hospital on Valentine's Day. With the help of their Advisor Dr. Carolyn Spillers, President Breanna Mack, Secretary April McCauley, and the rest of their members, the children enjoyed this special holiday.

On February 26, 2018, Fayetteville State University, in partnership with the Carolina Small Business Development Fund (CSBDF), and the U.S. Economic Development Administration (EDA), announced Forward Cape Fear, a program providing emerging entrepreneurs and existing small business owners with significantly improved access to funding through training and mentorship support programs.

The program will focus on underrepresented populations in Bladen, Cumberland, Harnett, Hoke, Robeson, and Sampson counties in North Carolina. Participants will be required to complete coursework on key business success factors and core competencies shown to be critical for entrepreneurial success and are required to perform market tests to confirm viability of their proposed business models.

After successful completion of the program through pre-screened and pre-qualified cohorts, entrepreneurs will be eligible for consideration of start-up microloans in the amount of \$500 – \$2,500 from CSBDF. Existing business owners seeking funding to expand operations or improve profitability can gain access to pre-loan guidance, consultations tailored to their specific business needs, and be recipients of larger working capital loans averaging \$25,000 each.

Heading the program is FSU alumnus and Director, Malika Mercer. Ms. Mercer returns to Fayetteville State University from the University of North Carolina at Pembroke, having begun her career in higher education as a staff member in the College of Business and Economics in 2005, later serving in the College of Arts and Sciences.

"It means so much to return 'home' to serve the institution and community that has played a pivotal role in my growth, both academically and professionally. I am deeply appreciative to Interim Provost Dr. Pamela Jackson and Interim Dean Dr. J. Lee Brown, for entrusting me with this opportunity and look forward to collaborating with campus and community constituents to raise awareness of economic development and entrepreneurial opportunities for underrepresented populations."

What to Bring:

- Proof of identification (photo ID)
- Social Security cards or Individual Taxpayer Identification Numbers (ITIN) for you, your spouse, and/or dependents
- Proof of foreign status, if applying for an ITIN
- Birth dates for all on the tax return
- For married filing joint, both spouses must be present
- All Forms W-2, W-2G, 1099 and 1098
- A copy of last year's federal and state returns
- Proof of bank account and routing information if choosing direct deposit of refund (e.g. voided check)
- Total paid to daycare provider and their tax ID
- Health insurance exemption certificate, if received
- All Forms 1095 Health Insurance statements

One-on-one Tax Return Preparation Services (VITA/TCE)

Each year, the Volunteer Income Tax Assistance (VITA) and the Tax Counseling for the Elderly (TCE) programs offer free, face-to-face tax help to people with low-to-moderate income. IRS-tax law certified volunteers provide this free service with electronic filing to all people who qualify. All you have to do is bring your documentation, and we'll do the rest.

Please bring your health insurance information, Tuition Statements, all your tax information and the information you have from the left column. Please beware that if you forget to bring your Picture ID and/or SS Cards we will not be able to assist you until you have them.

CBE OFFERS TIME AND SERVICES TO IRS VOLUNTEER INCOME TAX **ASSISTANCE PROGRAM (VITA)**



The Volunteer Income Tax Assistance Program (VITA), is a program that provides free tax assistance to undeserved communities for low-to-moderate income families or individuals, the disabled, the elderly, and limited English speaking taxpayers. This program has been made possible through the volunteer efforts of accounting faculty and students.

In order to become a certified volunteer, the students were required to complete 15 hours of training and pass a variety of certification exams. We have 11 students who passed the exam and are certified IRS VITA volunteers, and 10 of those students have actively been volunteering: Briana Brown (Vice President), Shajntara Rhodes (Secretary), Tia White (SCREP Reporter), Anatica Wilson, April McCailey, Autumn Davis, Arquistta Vaughan, Jacquanesha Leak, Lerona Pollard, and Walter Exume. FSU has a long history of serving America's military and veteran communities. Through the VBOC, FSU offers training to U.S. veterans transitioning from active duty to civilian life with the dream of starting their own business.

Veteran Entrepreneurship & Access to Capital Program

In January 2018 the VBOC partnered with Carolina Small Business Development Fund to announce a new initiative with JP-MorganChase & Co to increase veteran entrepreneurship lending. VBOC sponsored an introductory educational program at which attendees learned about resources and programs available for veteran-owned small businesses.

Entrepreneur Boot Camp for Veterans (EBC)

The Entrepreneur Boot Camp for Veterans (EBC) was founded by the VBOC in conjunction with the FSU College of Business and Economics in 2010. The EBC is offered each spring with a graduating class of approximately twenty-five veteran entrepreneurs. Taught by experienced presenters, small business owners, and other professionals, the EBC is a week-long immersion class that covers the fundamentals of a small business start-up using the business model canvas.

This year's EBC was held March 12 - 16, 2018. During this event a pitch competition was introduced, sponsored by the Carolina Small Business Development Fund. Three winners were chosen to win seed money to assist with starting their business.

January - March 2018 Events

The VBOC held 40 training events from January 1 to March, 2018, attended by 744 veterans, spouses, guard, reserves, and family members.
