Welcome Back!

BRONCOS! The start of the academic year is well underway. This edition of Money Matters is designed to inform you of important processes and updates in financial aid.



VERIFICATION. If you have not been awarded your financial aid for the academic year due to verification, it is important to complete that process as soon as possible. Please log onto <u>www.sscwp.org</u> to complete the verification process through School Servicing Center or stop by the Office of Financial Aid to submit the requested documents listed on Banner Self-Service.

FIRST-TIME LOAN BORROWERS. In order for your student loans to pay, you must have completed the Entrance Loan

Counseling and Master Promissory Note via <u>www.studentloans.gov</u>. You must use your Federal Student Aid ID (FSA ID) to log into the website.



Got A REFUND? Federal regulations require that students are informed of their eligibility for any federal aid, including subsidized and unsubsidized loans. If your financial aid award package includes loans, your excess funds are being disbursed from those student loans. Large refunds related to excess borrowing of loan funds can lead to excessive loan debt and reaching your aggregate (maximum) loan limit. Please be sure to review the National Student Loan Data System (www.nslds.ed.gov) to be in the know concerning your student loans.

2016/2017 FAFSA AVAILABILITY. The FAFSA for next academic year will be available beginning January 1st. Please ensure that you, and your parent if you are a dependent student, have created the required FSA ID. The process can be completed online at <u>www.fsaid.gov</u>. Our priority deadline for FAFSA completion is March 1st.
