### Office of Financial Aid FAQ

**BRONCOS** at the beginning of the 2016-2017 academic year, it is important to answer some Frequently Asked Questions regarding Financial Aid.

What is Financial Aid? Financial Aid is money (grants, loans, Federal Work Study, and scholarships) provided by various agencies to help students meet the cost of attending college.

What types of aid are available to you, the student? There are four main types of aid: grants, Federal Work Study, scholarships, and loans.

- Grants such as the Federal Pell grant, Federal SEOG, and UNC Need – Based grant, are free assistance that does not need to be repaid.
- Federal Work Study provides an opportunity for students to work and earn money for educational expenses.
- Scholarships are provided through various university departments and external agencies. Scholarships do not need to be repaid.
- Loans, such as the Federal Direct Subsidized/Unsubsidized loans, are low interest loans that need to be paid back after graduation or when you cease to be enrolled at least half-time.

**Does my enrollment status determine the amount of financial aid I will receive?** The number of credit hours in which you are enrolled plays a major role in determining the amount of aid available. The Federal Pell grant is adjusted for students enrolled less than full-time. In order to receive student loans, you must be enrolled at least half-time.

What is Satisfactory Academic Progress? All financial aid recipients must show academic progress to maintain eligible for financial aid. Students must earn at least 67% of their attempted hours while maintaining a minimum GPA of 2.0 for undergraduate and a minimum GPA of 3.0 for graduate students, and not exceed 180 total hours.

### How to Accept Your Award

All grants and scholarships are automatically accepted on your behalf. If you are interested in receiving student loans, you are required to accept, decline, or adjust part of your Federal Direct Student Loans in Banner Self-Service at <u>www.uncfsu.edu</u>. Below are step-by-step instructions on how to accept/decline your loans:

- 1. Log into Banner Self-Service (www.uncfsu.edu/banner).
- 2. Select Student and Financial Aid
- 3. Select My award Information
- 4. Select Accept Award Offer by Aid Year.
- 5. From the drop down box, select 2016-2017.
- 6. Click the Accept Award Offer Tab.
- 7. For each loan awarded, select Accept, Decline, or Adjust.

If you are a First – Time borrower, before your loans will pay to your account, you are required to complete the following by logging into <u>www.studentloans.gov</u> with your Federal Student Aid (FSA) ID username & password:

- 1. Complete the Entrance Loan Counseling
- 2. Sign the Master Promissory Note

If you are receiving loans for the first time, your loans will pay after 30 days of enrollment with the above requirements completed.
