**STUDENT AGREEMENT for using GI BILL Benefits**

**I understand** the Department of Veterans Affairs will **NOT** pay for the following:

- (a) Courses for which transfer credit awarded.
- (b) Credits given to Veterans automatically (HEED 112 & PEDU 140) from Joint Services Transcript and CCAF.
- (c) Courses that a passing grade was received **unless** it is necessary to receive a “C” grade for major or pre-requisite

**It is my responsibility** to contact **Department Professional Advisor** during Pre-Registration, and at any other time, to ensure that I do not duplicate courses, and register for those courses applicable to my major.

**It is my responsibility** to Waive the Student Health Insurance if I have the proper HEALTH coverage. (VA will not pay for Student Health Insurance because you simply FORGOT to waive it).
