TEST SCORE REQUIREMENTS

- Must take and pass the **PRAXIS CORE ACADEMIC SKILLS FOR EDUCATORS TEST (C.A.S.E.)** with the following scores **Reading (156), Writing (162) and Math (150).**
 - Individuals with a composite score of 468 on Praxis I Core Academic Skills for Educators: Reading, Writing and Mathematics shall be deemed to have satisfied this requirement.
 - However, individuals with a total SAT[®] score of 1100 (Verbal and Quantitative only) are exempt from Core testing requirements for an educator preparation program administration.
 - Individuals with a total SAT score of less than 1100 (Verbal and Quantitative only), but a score of at least 550 on the Verbal test, are exempt from the Core tests in Reading and Writing for educator preparation program admission.
 - Individuals with a total SAT score of less than 1100 (Verbal and Quantitative only), but a score of at least 550 on the Math test, are exempt from the Core test in Mathematics for educator preparation program admission.

- Likewise, individuals with a composite **ACT**[®] score of 24 are exempt from Core testing requirements for educator preparation program admission.
 - Individuals with a composite ACT score of less than 24, but with a score of at least 24 on the English test, are exempt from the Core tests in Reading and Writing for educator preparation program admission.
 - Individuals with a composite ACT score of less than 24, but a score of at least 24 on the Math test, are exempt from the Core test in Mathematics for educator preparation program admission.

Beginning **July 1, 2018**, candidates participating in edTPA will be exempt from the Principles of Learning and Teaching (PLT) assessment requirement if they can produce evidence of meeting the NC DPI established passing standard for the officially scored assessment.

The North Carolina Department of Public Instruction has established a passing threshold for edTPA. The following table lists the NC DPI approved edTPA cut scores: The NC-established passing threshold for 2018–2019 will remain for the 2019–2020 program year. *The cut scores for 2020–2022 are estimates until North Carolina data collected over 2017–2020 can be analyzed to determine North Carolina-specific cut scores beginning in 2020–2021. Note - Handbooks with only 13 rubrics include World Language and Classical Languages. Handbooks with 18 rubrics include the two Elementary Education handbook options. All other edTPA handbooks consist of 15 rubrics.*
