Notice is being provided to the campus community of an alleged crime reported to have occurred near Fayetteville State University Campus. We are sending this message for you:

- To protect yourself and others in our community
- To notify you that there may be a threat to the campus or near the campus
- To help with the investigation of possible crimes

On October 18th, 2022, at approximately 9:34 p.m. The Fayetteville State University Police Department was notified of a shooting with injury that took place in the 1800 Block of Slater Ave. Fayetteville Police advised the suspect was operating a White in color Chrysler 300 with a black in color rear bumper, License Plate HKW-2523. Both the suspect and victim were known to each other. The suspect was last described as a black male wearing a Fed Ex Uniform operating the above vehicle North on Murchison Rd.

Suspect Information: Suspect is known to Fayetteville Police at this time.

The Fayetteville Police Department is investigating the incident.
